Seniors Law has 10 years' experience designing and delivering legal services in health care settings. In 2017 the Victorian Health Promotion Foundation recognised the value of our work to address elder abuse, awarding our Health Justice Partnership (HJP) with cohealth a VicHealth award for "Improving Health Equity".

The successful applicant will play an active role in all aspects of the work of Seniors Law Victoria but will predominantly be working within our HJPs, including with cohealth, St Vincents and Alfred Health. The successful applicant will have the opportunity to work closely with supportive health teams, older clients, pro bono firms and evaluators.

In the context of COVID-19, the way in which legal, education and other services are delivered to potentially vulnerable people present enormous challenges and opportunities. New approaches to service delivery and legal education are being tested by Justice Connect and Seniors Law. Delivery of this project may include the provision of digital and remote strategies.

The role presents a unique opportunity to be part of an innovative, multi-disciplinary service for older clients experiencing, or at risk of, elder abuse. The successful applicant will build on the significant work embedding the legal service in a health setting, having established relationships with many teams and staff from all levels of the organisation. With high levels of trust between professionals, there is a greater capacity to collaborate to address legal and non-legal issues for older people experiencing elder abuse. The HJP is a highly effective model to address complex elder abuse matters as well as provide opportunities for early intervention.

Not only will the successful applicant receive mentoring, training and support from Justice Connect to develop a specialisation working with older people and in HJPs, but they will also feel part of the supportive health teams within our HJPs, where they can develop their understanding of the health sector and improve both legal and health outcomes for clients who are experiencing significant disadvantage.

If you are enthusiastic, driven, organised, enjoy working with both older clients as well a broad range of stakeholders, and have a minimum of five years post-admission experience, we would like to hear from you. ## Role purpose

The Principal Lawyer (Vic) of Seniors Law will be responsible for providing legal advice and secondary consults for help-seekers within our Health Justice Partnerships (HJPs) in Victoria; supervising the program's legal practice in conjunction with the Seniors Law Principal Lawyer (NSW); and delivering activities in the work plan.

### Key responsibilities

- Supervise legal services provided by the Seniors Law lawyers in Victoria, and lead staff to achieve the highest professional standards
- Provide high quality legal advice to help-seekers, undertake casework, and provide secondary consultations to health staff within our HJPs
- Oversee referrals to pro bono firms, and provide guidance and support to pro bono lawyers
- Design, supervise and conduct training on relevant issues for health professionals, staff and pro bono lawyers
- Maintain existing and establish new relationships with partner agencies, participating law firms and other relevant stakeholders
- Promote and publicise HJPs, including by representing HJPs in a range of public forums, the media and by contributing to internal and external publications
- Identify casework trends and systemic problems impacting on older people and engage in various initiatives including projects, law reform and advocacy activities to address these problems
- · Contribute to organisational and program-specific projects and policy and advocacy work
- Alongside the Seniors Law Principal Lawyer (NSW), participate in and share the leadership of the Practice Management Group (PMG) responsible for Justice Connect's compliance with practice management requirements including accreditation and insurance



- Ensure that HJPs comply with governance and funding requirements, including reporting and evaluation requirements of the Justice Connect Board and external funders
- Contribute to, and where relevant take ownership of, organisational processes, process improvement projects, integration of digital channels to service models, increased cross-organisation consistency and undertake quality assurance measures
- Contributing to Justice Connect's Reconciliation Action Plan activities.
- Perform other duties as directed and necessary to the proper performance of the role
