In the face of rising levels of unmet legal need, Justice Connect designs and delivers high impact interventions to increase access to legal support and progress social justice.

We deliver services that assist both people and community organisations. Those we assist often struggle to navigate the law, are unable to use the law in their daily lives and experience the impacts of harsh and unjust laws. We aim to prevent and to solve legal problems so that we can prevent the negative impacts on people's lives and organisations and empower the community to use the law as a force for good.

Given the scale of the challenges we address, we use digital innovation to extend our reach and impact, supporting us to be more efficient and accessible, while helping us capture and use data to better understand legal need and underlying systemic issues.

We harness the extraordinary pro bono contributions of over 50 member firms and the barristers we work with across the country. We channel pro bono effort through our innovative service models to ensure that pro bono hours deliver real impact for the community.

We develop strategic interventions to help address the system-level drivers of legal problems and barriers people face when engaging with the legal system. By addressing root causes of flawed or unfair laws and poorly designed systems, we prevent the long-term challenges that people and organisations continue to face.

Our creative and passionate staff drive us forward with a commitment to evaluation and iteration that ensures our impact increases year on year.

Seniors Law delivers client-centred interventions to increase access to legal support and progress social justice for older people experiencing or at risk of Elder Abuse. We increase the capability of health workers and community partners to identify legal issues for older people and refer them to our programs for specialist support. We advocate for change and increase awareness of sector organisations, government, industry and community on the nature and impact of Elder Abuse.

Seniors Law has operated for over 15 years alongside our health and pro bono partners. For over a decade, our Victorian team has used the Health Justice Partnership (HJP) model across up to 5 HJP sites, to reach vulnerable clients who are experiencing or at risk of elder abuse – an issue that is largely hidden and complex in which to intervene and provide legal support. Our partnerships provide holistic and specialist support to address both legal and non-legal causes and consequences of elder abuse. In 2016 we established our NSW Seniors Law team which has now grown to three HJPs across Sydney and a strong relationship with the Murrumbidgee Local Health District. Our HJPs involve our lawyers working on-site several days per week across the various health services. In November 2019 we also launched a Telehealth Pilot Project, to examine how Justice Connect can use existing telehealth facilities to increase access to legal help for people experiencing or at risk of elder abuse.

The Lawyer or Senior Lawyer - Access to Justice will be responsible for developing and delivering a high-impact project to increase access to justice for older Australians. Using a range of engagement strategies, the Lawyer or Senior Lawyer will extend Seniors Law's reach beyond our HJPs, deliver and facilitate education sessions for the community and support workers on preventing elder abuse using safeguarding tools, and connect many more people experiencing or at risk of elder abuse to Justice Connect's multi-channel services, including direct legal help via TeleLaw. The successful applicant will have the opportunity to work closely with all Justice Connect programs, supportive health teams, older clients, pro bono firms and evaluators.

The role presents a unique opportunity to be part of an innovative, multi-disciplinary service for older clients experiencing or at risk of abuse. The successful applicant will be critical in building on our significant history of HJP work, and the work of our pilot project to deliver legal services to patients in rural and regional NSW and/or Victoria, to trial new strategies to increase access to help and impact for people experiencing or at risk of elder



abuse. The role also builds on Justice Connect's work using safeguarding documents as a prevention strategy for elder abuse, facilitating conversations about arrangements as we age.

The successful applicant receive mentoring, training and support from Justice Connect to develop a specialisation working with older people and their support services. It is critical for this role to take a big picture approach to unmet legal need — delivering/facilitating education sessions and directing people in need to appropriate intensities of services (including self-help resources, TeleLaw advice and facilitating intensive probono representation).

If you are enthusiastic, driven, organised, enjoy working with both older clients as well a broad range of stakeholders, and have a minimum of two years post-admission experience, we would like to hear from you. This is a fantastic opportunity to join a very committed team who share your vision of a fairer society.

We know our team and our organisation is stronger with a diversity of backgrounds and experience, including lived experience of the issues we work on. Role purpose

Develop and deliver a high impact project to extend the reach of Justice Connect's Seniors Law services beyond our HJPs. Build on Seniors Law's unique work facilitating conversations about safeguarding through future planning, to deliver an effective prevention strategy for elder abuse. Trial various engagement strategies to build knowledge and relationships with older people and their supports, to identify and refer elder abuse and prevention matters to Justice Connect's services. Work with Justice Connect's engagement team to monitor and help improve digital engagement strategies. Take a big picture approach to unmet legal need and directing people in need to appropriate intensities of services (including self-help resources, TeleLaw advice and facilitating intensive pro bono representation). Build on and deliver Seniors Law's Telelaw service across all health partner local health districts. Work closely with health teams, local community support organisations, older clients, pro bono firms and evaluators to deliver improved legal and health outcomes for older people experiencing or at risk of abuse.

Key responsibilities

Lawyer or Senior Lawyer – Access to Justice

- Stakeholder mapping to identify key project stakeholders.
- Develop and deliver an engagement strategy to reach more older people who may be at risk of or experiencing elder abuse, and their supports, with support from the Projects Manager.
- Work with Justice Connect's engagement team to monitor, improve and understand the impact of digital engagement strategies being run in parallel with more traditional engagement strategies for this project.
- Deliver legal education to older people, their support workers and other community organisations to increase understanding of elder abuse and preventative strategies.
- Facilitate conversations with the community about safeguarding and future planning key strategies for preventing elder abuse.
- Conduct intensive legal triage with clients experiencing, or at risk of, elder abuse and other legal issues associated with ageing, and identify the appropriate intensity of Justice Connect's services for the client.
- Continue to develop Justice Connect's telelaw program and deliver telelaw services where appropriate considering the needs and circumstances of the client.
- Oversee referrals to pro bono firms, including providing guidance to pro bono lawyers and responding to clients.
- Provide secondary consultations on a range of legal issues to build capacity and assist developing strong relationships with health professionals
- Escalate risk and legal practice management issues to the Manager.
- Identify casework trends and systemic problems impacting on older people and engage in various initiatives — including projects, law reform and advocacy activities — to address these problems.
- Develop and maintain collaborative relationships with key stakeholders, in particular, health professionals, pro bono lawyers, evaluators, other community services, networks and funders.
- Collect data to assist with monitoring and evaluation.
- Participate in working groups and committees focused on the legal rights of older people.



- Actively participate in promotion activities, including by representing Justice Connect in a range of public forums, delivering presentations and contributing to internal and external publications.
- Assist with the governance, fundraising, reporting and evaluation requirements of the program including reports for the Justice Connect Board and funders.
- Contribute to program and organisation-wide projects
- Contributing to Justice Connect's Reconciliation Action Plan activities.
- Assist with program evaluation
- Perform other duties as directed and necessary to the proper performance of the role.

Senior Lawyer - additional responsibilities

- Assist with budget management
- Oversee and develop projects, co-located services, and targeted work with specific help-seeker groups
- Contribute to and as required lead organisational processes, process improvement projects, integration of digital channels to service models, increased cross-organisation consistency and undertake qualify assurance measures.
