Given the scale of the challenges we address, we use digital innovation to extend our reach and impact, supporting us to be more efficient and accessible, while helping us capture and use data to better understand legal need and underlying systemic issues.

We harness the extraordinary pro bono contributions of over 50 member firms and the barristers we work with across the country. We channel pro bono effort through our innovative service models to ensure that pro bono hours deliver real impact for the community.

Justice Connect's **Access Program** is a multidisciplinary team of 20 staff with in-house legal, data, project, and service design expertise. We have expertise in dealing with issues that have escalated to court proceedings with a long history of running court-based services across a range of jurisdictions.

Our legal services use a range of approaches including specialist advice, pro bono referrals (leveraging our network of over 10,000 pro bono lawyers) and online resources to help people experiencing legal problems. We also operate weekly pro bono clinics for help seekers involved in litigation in Victorian courts, Federal courts and VCAT.

Our strategy commits us to identifying ways to scale legal help with digital solutions, including our in-house developed digital platform, Justice Connect Answers (JCA). We seek to identify and respond quickly to emerging legal need in the community. In all our work, we centre client experience and our commitment to impact.

We know our team and our organisation is stronger with a diversity of backgrounds and experience, including lived experience of the issues we work on. Aboriginal and Torres Strait Islander people, people of colour, people from culturally and linguistically diverse and refugee backgrounds, people with diverse religious beliefs, gender diverse people, LGBTIQ+ people and people living with a disability are strongly encouraged to apply.

# Role purpose

### The Lawyer role:

- delivers services to vulnerable and disadvantaged members of the community, through both one-to-one
  and one-to-many assistance, with a particular focus on our Domestic Building Legal Service (DBLS) and
  Justice Connect Answers (JCA).
- assists with maintenance and development of new self-help tools and digital interventions to scale assistance in response to unmet legal need.
- provides subject matter expertise to our innovation work focused on service improvements and working
  effectively with stakeholders with an initial focus on implementation of recommendations arising from
  evaluations of both DBLS and JCA.
- monitors for emerging trends in the types of legal problems and challenges encountered by vulnerable help-seekers to support strategic work focused on addressing system-level issues and improving access to justice.

## Key responsibilities

- Provide legal assistance to help seekers across Access Program, including taking a clinic lead role in the Domestic Building Legal Service and Justice Connect Answers. This includes providing, checking and supervising (through a Nominated Person delegation) the intake and delivery of unbundled legal services delivered by the Access Program.
- Manage lawyers and paralegals, as required.
- Together with the Innovation Manager and Principal Lawyer Innovation, collaborate on Access Program
  initiatives focused on responding to emerging legal needs and continuous improvement.



- Work as part of a team to pilot service delivery as part of identified new approaches and projects being trialled.
- Design and develop online resources and tools in line with strategy to increase the number of people that the team assists and deliver a multi-channel and multi-intensity approach.
- Contribute to monitoring and evaluation of service delivery and program projects
- Build and maintain stakeholder relationships
- Support the leadership team of the program to implement the team and organisational strategy, including
  collaborating with other Justice Connect programs where required. This may involve work to improve how
  the team identifies and responds help seekers with multiple issues, the way in which the team
  collaborates to respond to need, and how it identifies efficiencies and opportunities for impact.
- Escalate risk and legal practice management issues to a Principal Lawyer or Manager.
- Contributing to Justice Connect's Reconciliation Action Plan activities.
